#### Urban Plan

In the last few weeks we have been faced with a project whereby 18 lots would be developed in a second row of cottages with access to the lake through a jointly -owned lot. These lots are located between Ernest creek and the beach west of the public landing.

This is a precedent at the lake. The concentration of activities resulting from such projects will affect our tranquility and could have a negative impact on the lake's ecological balance. The first to be affected will be the neighbours with cottages directly on the lake. But we could all be affected, especially if other similar projects are developed. This is possible anywhere around the lake.

Such projects were permitted under the old zoning by-law and are still allowed under the new urban plan, inasmuch as the projects are residential. This type of residential development with access to the lake through one lot was never brought up during the information sessions on the urban plan. Therefore, there did not appear to be any need to address this possibility during the discussions.

Before asking the municipality to take measures regarding such projects the APLG needs to know if a majority of members are opposed to such development. We need to show the authorities that such opposition exists to justify our actions and give them some strength. We are, therefore, asking you to take a few minutes to complete the attached short opinion poll.

# Invitation from CRED


The "Corporation récréotouristique et économique de Duhamel" (CRED) has asked the APLG to appoint a representative to its Board of Directors.
