## THE AFTERMATH OF THE REFERENDUM

The message could not have been clearer. 98.3% of Duhamel residents and 95.5% of Alliance des municipalités Petite-Nation Nord members voted against Lomiko Metals' graphite mining project. So, given that this referendum was consultative and not binding, what do we do with these results?

The task now is to use the political leverage that these results provide. The Alliance, which held the referendum, heard its citizens loud and clear and undertook to call on the government to halt the mining project. It did so by unanimous resolution of the five municipalities, for which it obtained the unanimous support of the 25 municipalities of the Papineau RCM.

With this support and that of our representative, Mathieu Lacombe, the Alliance, the RPLPN, and the group of business people opposed to the Loutre project were able to secure a personal meeting with the new Minister of Natural Resources, Jean-François Simard. After informing him of the issue, we asked him, given the absence of social acceptability as demonstrated by the referendum, to respect their election promise

and do everything possible to stop this project (using section 304 of the Mining Act).

Early indications from the ministry do not suggest a suspension, but rather a promise not to invest in the project and to wait for a decision from the BAPE (*Bureau d'évaluation environnementale du Québec*) if the company reaches that stage.

In the meantime, the company, acting as if the referendum had never taken place, has announced that sampling work (involving blasting) will be carried out on the property between November 23 and February 23.

That's the situation at this point. With the municipal elections over, we will soon be meeting with the Alliance and business people to decide on the next steps and how to respond to the site work that Lomiko will be undertaking in a few weeks.

On a positive note, despite the federal government's announcement of numerous grants for graphite and critical minerals mining projects in southern Quebec in recent days, Lomiko Metals' name is nowhere to be found on the list of selected projects. We cannot be entirely sure, of course, but it is possible that the referendum's unequivocal message has been heard. To be continued.

## MARIE-LEFRANC-PETITE-NATION PROTECTED AREA

The project is progressing and is currently in the regional consultation phase in both the Papineau and Laurentides RCMs, where it is located. Covering an area of 117 square kilometres, it is one of the major projects that have been presented. It has been favourably reviewed by the Ministry of the Environment, particularly because of the presence of three old-growth forests, two biological refuges, important habitats for aquatic wildlife, and its key position in a vast ecological corridor project.

It will now be evaluated along with all the other projects by a panel of scientists, environmental specialists, forestry industry representatives, and various land users. This panel will have to reach a consensus in order to select the projects

to be retained, with the overall goal still being to cover 30% of Quebec's territory. It is worth noting that currently only 5% of the Papineau RCM's territory is protected.

The project is of interest to Lac Gagnon residents since its western border runs along the eastern side of our lake and the entire Petite-Nation Nord River (see map).

The project is being proposed by the RPLPN and piloted by Louis St-Hilaire. A final decision is expected in 2027. We will keep you informed of developments.

#### LAKE WATER LEVEL

What a magnificent fall we've had at the lake! However, the dry weather has led to a record low lake level. This raises legitimate concerns about traffic on the lake, getting boats into and out of the water, and drinking water intake pipes. Fortunately, with the rain we've had recently, the lake level has already risen by 15 cm. You can follow changes in the water level and view all the statistics on our website.

#### SWIMMING WATER TESTS

The water quality at Lac Gagnon remains excellent. Around 50 samples were taken in early August from various locations around the lake and in the river. A dozen additional samples were taken two weeks later to validate certain results. All of the results were excellent. You can view the results in detail on our website.

#### SENTINELLES PROJECT

The Lac Gagnon sentinels carried out their survey of the lake once again this summer. No signs of Eurasian watermilfoil were observed. However, there appears to have been more abundant growth of Elodea this year at Lac Gagnon and Lac Simon. This native plant is not dangerous, although it is unpleasant to walk on. The drop in water level and high temperatures could explain the proliferation of this fast-growing plant.

#### **PERIPHYTON**

We are now in our third year of the periphyton monitoring study. It is difficult to detect a significant difference in its growth in such a short period of time. However, if you have been visiting the lake for several years, you may have noticed that there are many more slimy deposits accumulating on rocks, boats, and other structures during the summer. This is an early sign of lake aging. We will continue to study the phenomenon, but in the meantime, we must limit the amount of nutrients, including phosphate, entering the lake as this undoubtedly accelerates its aging.

#### **SHORELINE**

How can we protect the lakeshore? The buffer zone is 10 metres on flat ground and 15 metres on sloping ground. In this fragile territory, we are not permitted to add landfill, mow the grass, or cut down vegetation. A 5-meter-wide strip may be cleared to provide access to the lake. We have chosen to settle on the shore of a magnificent lake. We must therefore try to live in harmony with nature and preserve ecosystems and their habitats, which are

already affected by climate change. The same applies to preserving the quality of the water, which cannot absorb more nutrients resulting from rainwater runoff into the lake. It is essential that runoff water be slowed down and filtered by vegetation along the lake's edge to prevent eutrophication, or premature aging of the lake, and blue-green algae blooms. That is why the municipality of Duhamel will ensure that the current regulations are enforced!

The APLG has received a grant from the provincial government to help residents correct or optimize their shorelines. The OBV is also a valuable partner with expertise in this area. #### WATERCRAFT WASHING

Another effective measure in our efforts to preserve water quality and combat invasive species is the systematic washing of all watercraft and equipment that travel from one body of water to another. The system already in place in the village of Duhamel will continue next year. In addition, we will now have a hot water pressure washing station at the start of next season at the Lac Gagnon boat launch. Washing will be free. Non-resident access fees will be managed by the municipality. More details on this subject will be provided in the spring.

#### COOPERATIVE PROJECT

The cooperative is continuing its efforts to save the gas station in Duhamel. A board of directors has been formed, chaired by Sophie Legault, a Lac Gagnon resident. For information, go to the Coop's website: Coop Duhamel.
